Public meetings may be recorded. At the start of the meeting the Chairman will confirm if all or part of the meeting is being audio recorded. The whole of the meeting will be recorded, except where there are confidential or exempt items. Therefore, by entering the Meeting and/or speaking at Committees you are consenting to being recorded and to the possible use of those sound records for training purposes.

The meeting will be open to the public and the press unless the Council directs otherwise.

**The Chairman will ask Members if they have any interests to declare in respect of items on this agenda, under the following headings:**

**a) Disclosable Pecuniary Interests (DPI)** under the Localism Act 2011. The nature as well as the existence of any such interest must be declared. After declaring a DPI, the Member must leave the meeting and not take part in the discussion or vote. This applies even if there is provision for public speaking.

**b) Disclosable Non- Pecuniary (DNPI)** under the Code of Conduct adopted by the Council in May 2012. The nature as well as the existence of any such interest must be declared. After declaring a DNPI interest, the Member may stay, speak and vote on the matter.

**c) Where it is possible that a fair-minded and informed observer, having considered the facts would conclude that there was a real possibility that the Member might be predetermined or biased the Member should declare their predetermination or bias and then leave the room while that item is considered.**
